Day by Day Itinerary

19 de marzo Día 1: Salida de EE.UU. – Vuelo a Tierra Santa: Salida en vuelos hacia Tierra Santa. Cena a bordo, relájese y prepárese para su llegada al día siguiente.

20 de marzo Día 2: Llegada a Tierra Santa: A nuestra llegada a Tierra Santa, somos recibidos por nuestro representante de Holy Land Travel Center y trasladados a nuestro hotel en Belén para la cena y alojamiento.

Alojamiento: Belén (Desayuno, Cena)

21 de marzo Día 3: Domingo de Ramos y Belén: Hoy nos unimos a los cristianos locales para conmemorar la entrada triunfal de Jesús en la ciudad, menos de una semana antes de la Crucifixión. El evento se conmemora en la Liturgia con la Procesión Solemne, que en Tierra Santa sigue aproximadamente el mismo camino que tomó Jesús. La procesión comienza en la Iglesia Franciscana de Betfagé en el Monte de los Olivos y continúa hasta la Iglesia de Santa Ana en la Ciudad Vieja de Jerusalén. Por la tarde nos dirigimos a los Campos de los Pastores, donde los ángeles anunciaron el nacimiento de Jesús. Luego visitamos la Iglesia de la Natividad en Belén, que se encuentra en el lugar donde nació Jesús. Cena y alojamiento en nuestro hotel.

Alojamiento: Belén (Desayuno, Cena)

22 de marzo Día 4: Cesarea / Haifa / Nazaret: Después del desayuno, salimos hacia Cesarea Marítima para visitar las ruinas romanas y cruzadas antes de continuar a Haifa. Al llegar a Haifa, visitaremos Stella Maris, un monasterio carmelita con la Virgen del Monte Carmelo. Después haremos una parada en los Jardines Baha'i, que incluyen una escalinata de diecinueve terrazas que se extienden hasta la ladera norte del Monte Carmelo. Visitaremos la Basílica de la Anunciación donde celebraremos Misa. Luego continuamos a nuestro hotel en Nazaret.

Alojamiento: Nazaret (Desayuno, Cena)

23 de marzo Día 5: Tiberíades – El Ministerio de Cristo en Galilea: Hoy tomaremos un paseo en barco por el Mar de Galilea hasta Cafarnaúm para ver la sinagoga y la casa de San Pedro. Visitaremos el Monte

de las Bienaventuranzas, donde fue pronunciado el Sermón de la Montaña; Tabgha, donde veremos el espléndido mosaico que recuerda el milagro de los panes y los peces; y la cercana Iglesia del Primado de Pedro, donde Jesús le dijo: "Apacienta mis corderos, apacienta mis ovejas." Celebraremos una Misa inolvidable cerca de la orilla del Mar de Galilea, en el Primado o en el Monte de las Bienaventuranzas. Luego nos dirigimos al Centro de Magdala, el pueblo de María Magdalena, para visitar la iglesia recientemente construida y las ruinas excavadas.

Alojamiento: Nazaret (Desayuno, Cena)

24 de marzo Día 6: Caná / Monte Tabor / Río Jordán / Mar Muerto / Jericó: Después del desayuno, salimos hacia Caná, donde las parejas tendrán la oportunidad de renovar sus votos matrimoniales. Continuamos al Monte Tabor, lugar de la Transfiguración. Luego iremos al Río Jordán para recordar el bautismo de nuestro Señor. Después, llegaremos a Jericó para visitar las excavaciones de la ciudad más antigua del mundo y contemplar el Monte de la Tentación, donde Jesús ayunó y fue tentado por Satanás. De regreso, habrá tiempo para nadar (¡o mejor dicho, flotar!) en las aguas ricas en minerales del Mar Muerto, famoso por sus propiedades curativas.

Alojamiento: Belén (Desayuno, Cena)

25, 26 y 27 de marzo: Días 7, 8 y 9: Jueves Santo, Viernes Santo y Celebraciones con los locales: Durante estos tres días, nos uniremos a los habitantes locales en sus celebraciones en Jerusalén.

28 de marzo Día 10: Domingo de Pascua – Celebraciones: Esta mañana nos unimos una vez más a los locales para celebrar juntos la Santa Misa. Tendremos el resto del día para celebrar antes de regresar a nuestro hotel para la Cena de Pascua y alojamiento.

Terms & Conditions

By making any payments (cash, credit card or otherwise) towards any tour constitutes your unconditional acceptance of all the terms and conditions stated in this brochure. Holy Land Travel Center shall be referred to as HLTC within this document.

DOCUMENTS: US citizens require a valid passport. Other nationalities please inquire with the appropriate embassies.

REGISTRATION AND DEPOSIT: Deposit of \$500 per person is required upon registration along with a signed copy of the registration form. Registrations are processed in the order received by HLTC. Final payment is due 45 days prior to departure. Late payments are subject to a \$50 late fee per week past the due date. HLTC reserves the right to cancel reservations whose payments are 30 days late and to apply applicable cancellation/penalties indicated below. No registrations can be made over the telephone.

INDIVIDUAL CANCELLATION FEES & REFUNDS: Upon cancellation of participation of tour by you, the registrant, for any reason, and only after HLTC receives your written cancellation via email used to register or by US mail., HLTC will then refund your payment for services not received by you, minus applicable cancellation fees per person, according to the following schedule: All refunds will be processed via check. Credit card fees are collected by the payment processor and will not be refunded.

- 1) Minimum cancellation fee is \$500 from time of registration up to 120 days prior to the tour's departure date.
- 2) From 119 to 60 days prior to departure day, the cancellation fee is \$500 + 20% of total price.
- 3) From 59 days to 31 days prior to departure day, cancellation fee is \$500 + 50% of total price.
- 4) From 30 days prior to departure day onward, no refund is possible.

PAYMENT: Advertised price is the cash/check discounted price. If paying with a card a processing fee will apply. Card processing fee is nonrefundable.

BOUNCED CHECKS: Bounced checks will incur a \$25 administrative fee.

VOUCHERS: Travel vouchers issued by HLTC may be applied to a new trip after the initial deposit has been made. To ensure proper processing, all vouchers must be applied no later than 150 days prior to the new trip's departure date. Vouchers cannot be used to cover the initial deposit, nor can they be applied retroactively to previously booked trips. Failure to apply a voucher within the specified timeframe will result in forfeiture of its use for that particular trip. All voucher applications are subject to verification and approval by HLTC.

DISPUTED PAYMENTS: In the event of a disputed payment for reasons other than a fraudulent charge, the administrative fees associated with a dispute will be invoiced to your account and either deducted from your refund or invoiced to you. These fees are subject to change due to payment processors rules and regulations.

TRAVEL PROTECTION: Travel insurance is recommended to help protect you and your trip investment against the unexpected. For your convenience, we offer travel protection. If you do not wish to purchase now, the plan can be purchased any time before submitting your final payment. Coverage takes effect once payment is received. If you chose to purchase outside of the time sensitive period outlined in the plan, you will not be eligible for time sensitive benefits. All plan premiums are non-refundable. MEDICAL CONDITION: We endeavor to provide the highest level of service to all our passengers. Participants who require special assistance must be accompanied by a qualified helper who assumes total responsibility for the participants' well-being. This pilgrimage demands a lot of walking and can be strenuous. HLTC is not responsible for any medical conditions that occur prior to, during, or after the tour.

LAND TRANSPORTATION AND TRANSFERS: By private deluxe motor coach.

ACCOMMODATIONS: Tour prices are per person, based on two persons sharing double or twin-bedded rooms with a private bathroom with tub or shower. In the event that one does not sign up with a roommate and is not able to be paired with another traveler, there will be a single supplement charge to the account. Single rooms subject to availability and an additional cost indicated on the brochure. Accommodations are subject to change due to upgrade, size of group, etc.

MOBILE APP: Final pilgrimage details will be available through an app before departure. Please be aware that the information on the app is regularly updated and subject to change. HLTC (Holy Land Travel Company) holds no liability for errors or discrepancies in the app's content.

MEALS: Meals in accordance with the itinerary. All beverages are extra.

TIPPING: Unless it is specified in the tour brochure, the price of the tour does not include tips and gratuities. Tipping is recommended to the tour guide and motor coach driver approximately \$6 and \$4 per person, respectively, per day to each. Hotel tips are approximately \$2 per day per person. Tips may be pre-collected before the pilgrimage for your convenience.

AIRLINE TICKETS AND ITINERARY LENGTH: Air transportation to/from your destination will be economy class aboard carriers utilizing non-refundable, non-amenable tickets. Preliminary international flight schedules are available 60 days prior to departure and may change before they are finalized. Therefore, if you book the domestic flight on your own, you will be responsible for changing your domestic flights and incurring any change fees that would be generated by this adjustment. We are not responsible for changes and delays in airline schedules and do not reimburse passengers for expenses resulting from such occurrences. Travelers making their own flight arrangements should not purchase non-refundable, non-changeable tickets. We cannot guarantee the most direct routing to your final destination. If flight schedules change, we reserve the right to lengthen or shorten the itinerary accordingly, and if changes or flight schedules necessitate extra overnights, you will be charged at normal hotel rates. Land Only packages do not include airport-hotel transfers.

Note: While no changes are anticipated, there may be unforeseen occasions when certain alterations become necessary, either due to changes to the airline schedule, government regulations, travel restrictions, or any other reason. Holy Land Travel Center reserves the right to change the itinerary or name alternate dates due to such unforeseen circumstances or emergencies

SEAT ASSIGNMENT: THERE IS NO ADVANCE SEAT SELECTION FOR TOUR DEPARTURES. HLTC cannot guarantee specific seats, which are at the discretion of the airline and are pending availability. When HLTC disperses travel packages, you will receive your record locator. You can use this locator to do online seating arrangements, if permitted by the airline, any additional costs for seat selection are your responsibility. If your airline ticket is canceled for any reason, you must directly contact the airline to request a refund for your seat selection. The refund will be processed to your original form of payment, subject to the airline's terms and conditions."

BAGGAGE: Transatlantic and transpacific flights to and from the USA allow the passenger to bring one (1) checked bag, which may have a maximum weight of 50 lbs., and maximum combined dimensions of 62 inches. Also, one (1) "carry-on" with maximum dimensions of 8"x12"x20" is permitted. Luggage on domestic flights including Mexico & Canada will cost extra. Luggage is the passenger's responsibility and that of the airlines. For lost luggage, the passenger is responsible for notifying the airline directly. Check with your carrier regarding carry-on luggage rules and regulations.

PRICES: All prices are based on exchange rates and fares applicable at time of quotation and based on minimum number of paying passengers stated in the brochure and are therefore subject to change if fares change (including fuel surcharges increase), if group does not reach minimum or if exchange rates fluctuate. Minimum number of paying passengers is 20.

NOT INCLUDED: Passport and Visas, exit taxes, meals not mentioned, beverages with meals, extra beyond standard menu, excess baggage, luggage on domestic flights, telephone calls, fuel surcharges increase.

VISAS: When and if a visa or visa waiver is required, it is the passenger's responsibility to obtain one. HLTC, owner, agent, or employees cannot be held liable for clients not having proper passports, visa, visa waiver, or other travel documents. Cancellations or changes to schedule due to a lack of appropriate documents will incur usual penalties.

PASSPORTS: Passports are required to travel with Holy Land Travel Center. A Passport Card is not useful for International Air Travel. Attempting to use this instead of a Passport Book will result in a denial of boarding by the airlines and entry by the legal authorities.

PHOTO RELEASE: Photos taken on the pilgrimage may be used to advertise for future pilgrimages by registering for the tour you consent to photographs taken of during your participation in the tour, and to publication of the photographs by the Operator for advertising, promotional and marketing purposes. I assign a non-exclusive, royalty-free license to use, for any purpose, photographs submitted by me to Operator and any photographs taken of me during my tour. I waive my right to inspect or approve the eventual use of such photographs.

TRAVEL AUTHORIZATION FOR EUROPE & UK: Starting in 2025, travelers from the U.S., Canada, Australia, and other visa-exempt countries will need online travel authorization to enter most of Europe (ETIAS) and the United Kingdom (ETA). This applies to all travelers, regardless of age, and includes layovers in the UK. These are not traditional visas but require basic personal and trip information.

-ETIAS: Approx. \$9 USD per person for travel to Europe

-UK ETA: Approx. €16 per person, required even for transit through the UK

All information is subject to change. It is the traveler's responsibility to verify the most up-to-date entry requirements and obtain the appropriate authorizations. HLTC is not responsible for disruptions due to missing or incorrect travel documents.
