Day by Day Itinerary

Noviembre 2 Día 1: Salida: Nuestra peregrinación espiritual comienza al abordar nuestro vuelo transatlántico con destino a Praga. Durante el vuelo se servirán alimentos y bebidas.

Noviembre 3 Día 2: Llegada a Praga: Hoy llegamos a la "Ciudad Dorada" de Praga, una de las capitales más atractivas de Europa, y seremos recibidos por nuestro representante de Holy Land Travel Center. Posteriormente, traslado a nuestro hotel para cenar y pasar la noche.

Pernocte: Praga (Cena)

Noviembre 4 Día 3: Praga - Castillo de Praga, Catedral de San Vito, Puente de Carlos, Santuario de Loreto: Atravesada por el río Moldava, Praga es una de las ciudades mejor conservadas de Europa. La ciudad es famosa por su arquitectura gótica y barroca. Admiraremos la imponente grandeza del Castillo de Praga y la Catedral de San Vito, la Iglesia de Nuestra Señora de la Victoria y la estatua del Niño Jesús de Praga. Después de la misa, cruzaremos el histórico Puente de Carlos, construido en el año 1400, y admiraremos sus estatuas barrocas. Continuaremos hacia el Santuario de Loreto, uno de los lugares de peregrinación más importantes de Europa del Este. Recordaremos las obras maestras atemporales de Mozart, Wagner y Berlioz al contemplar los numerosos teatros y casas de ópera de la ciudad.

Pernocte: Praga (Desayuno, Cena)

Noviembre 5 Día 4: Praga / Cracovia - Velehrad Rosa de Oro: Salida por la mañana rumbo a Cracovia. En ruta, haremos una parada en Velehrad para visitar el santuario en memoria de los dos misioneros provenientes de Bizancio, San Cirilo y San Metodio, quienes llevaron el cristianismo a las tierras checas. En 1985, Su Santidad el Papa Juan Pablo II otorgó a Velehrad la distinción papal de la "Rosa de Oro", concedida únicamente a otros tres venerables lugares de peregrinación: Lourdes, Guadalupe y Czestochowa. Continuación hacia nuestro hotel para cenar y pasar la noche.

Pernocte: Cracovia (Desayuno, Cena)

Noviembre 6 Día 5: Cracovia - Monasterio de Jasna Góra, Virgen Negra, Auschwitz: Salida de Cracovia y traslado a Czestochowa, ciudad que durante los últimos 600 años ha sido el principal centro de la religión católica en Polonia y un importante santuario para peregrinos. Visitaremos el Monasterio de Jasna Góra, de gran valor religioso, histórico y artístico, y participaremos en la apertura del icono de la Virgen Negra. Nuestro guía nos mostrará la Capilla Gótica de Nuestra Señora, donde se encuentra el famoso icono de la Virgen Negra, colocado en un magnífico altar de plata y ébano. Visitaremos el tesoro y celebraremos misa en el santuario. Después del almuerzo, nos dirigiremos a Auschwitz para una visita guiada al infame campo de concentración donde millones de personas fueron asesinadas durante la Segunda Guerra Mundial. Regreso a Cracovia para cenar y pasar la noche.

Pernocte: Cracovia (Desayuno, Cena)

Noviembre 7 Día 6: Cracovia - Colina de Wawel, Iglesia de San Estanislao, Calle Kanonicza, Santuario de Santa Faustina: Después del desayuno, nos dirigiremos a la Colina de Wawel para

celebrar misa en la Iglesia de San Estanislao, el segundo santuario de peregrinación más importante de Polonia. Visitaremos la catedral de Cracovia, que sirve como la capital espiritual de la nación y ha sido testigo de la mayoría de las coronaciones y funerales reales del último milenio. Veremos el Tesoro de la Catedral y continuaremos hacia el casco antiguo de Cracovia para recorrer la Calle Kanonicza, donde residió el Papa Juan Pablo II durante su estancia en la ciudad. Visitaremos el patio del Collegium Maius; veremos la antigua Plaza del Mercado y la Lonja de los Paños. Por la tarde, haremos una parada en Łagiewniki para visitar el Santuario de Santa Faustina antes de regresar a Cracovia para cenar y pasar la noche.

Pernocte: Cracovia (Desayuno, Cena)

Noviembre 8 Día 7: Cracovia - Minas de Sal de Wieliczka, Wadowice, Kalwaria Zebrzydowska - Por la mañana, nos trasladaremos a Wieliczka para visitar la mina de sal más antigua de Europa, una atracción turística de clase mundial. Es un lugar único donde muchas generaciones de mineros polacos han creado un mundo subterráneo con lagos de sal y un rico interior de capillas decoradas, incluida la famosa Capilla de Santa Kinga, además de galerías y túneles tallados en sal. La Mina de Sal de Wieliczka está inscrita en la lista del Patrimonio Cultural Mundial de la UNESCO. Posteriormente, continuaremos hacia Wadowice, lugar de nacimiento de Karol Wojtyła, el Papa Juan Pablo II. Su museo se encuentra en su casa familiar. Más tarde, nos dirigiremos a Kalwaria Zebrzydowska, un popular lugar de peregrinación para el Papa cuando era joven. En el siglo XVII, el Palatino de Cracovia fundó ahí un monasterio franciscano. La iglesia cuenta con una rica decoración barroca. En la ladera del cerro y en el valle se encuentra un "Vía Crucis" arquitectónico compuesto por 42 capillas manieristas y barrocas, así como varias pequeñas iglesias del Calvario.

Pernocte: Cracovia (Desayuno, Cena)

9 y 10 de Noviembre – Días 8 y 9: Retiro Espiritual: Durante este tiempo, nos enfocaremos en la meditación, la oración y momentos de reflexión en silencio, guiados espiritualmente a lo largo de nuestros días de retiro. Participaremos en Ejercicios Espirituales, una práctica contemplativa diseñada para profundizar nuestra fe en este lugar sagrado. Nuestra vivencia incluirá la Adoración, el Sacramento de la Reconciliación y la celebración de la Sagrada Eucaristía. Este tiempo de reflexión nos invita a considerar nuestras vidas a la luz del amor infinito de Dios, especialmente a través del mensaje de la Divina Misericordia revelado a Santa Faustina Kowalska, su humilde instrumento.

Pernocte: Cracovia (Desayuno, Cena)

Noviembre 11 Día 10: Cracovia – Cierre del Retiro Espiritual y Tarde Libre: Esta mañana se dará por concluido nuestro retiro espiritual con la celebración de la misa matutina. Posteriormente, tendremos el resto del día libre para explorar Cracovia por cuenta propia.

Noviembre 12 Día 11: Regreso a casa: Hoy abordamos nuestros vuelos de regreso a casa, llevando con nosotros recuerdos y experiencias que perdurarán toda la vida.

Terms & Conditions

By making any payments (cash, credit card or otherwise) towards any tour constitutes your unconditional acceptance of all the terms and conditions stated in this brochure. Holy Land Travel Center shall be referred to as HLTC within this document.

DOCUMENTS: US citizens require a valid passport. Other nationalities please inquire with the appropriate embassies.

REGISTRATION AND DEPOSIT: Deposit of \$500 per person is required upon registration along with a signed copy of the registration form. Registrations are processed in the order received by HLTC. Final payment is due 45 days prior to departure. Late payments are subject to a \$50 late fee per week past the due date. HLTC reserves the right to cancel reservations whose payments are 30 days late and to apply applicable cancellation/penalties indicated below. No registrations can be made over the telephone.

INDIVIDUAL CANCELLATION FEES & REFUNDS: Upon cancellation of participation of tour by you, the registrant, for any reason, and only after HLTC receives your written cancellation via email used to register or by US mail., HLTC will then refund your payment for services not received by you, minus applicable cancellation fees per person, according to the following schedule: All refunds will be processed via check. Credit card fees are collected by the payment processor and will not be refunded.

- 1) Minimum cancellation fee is \$500 from time of registration up to 120 days prior to the tour's departure date.
- 2) From 119 to 60 days prior to departure day, the cancellation fee is \$500 + 20% of total price.
- 3) From 59 days to 31 days prior to departure day, cancellation fee is \$500 + 50% of total price.
- 4) From 30 days prior to departure day onward, no refund is possible.

PAYMENT: Advertised price is the cash/check discounted price. If paying with a card a processing fee will apply. Card processing fee is nonrefundable.

BOUNCED CHECKS: Bounced checks will incur a \$25 administrative fee.

VOUCHERS: Travel vouchers issued by HLTC may be applied to a new trip after the initial deposit has been made. To ensure proper processing, all vouchers must be applied no later than 150 days prior to the new trip's departure date. Vouchers cannot be used to cover the initial deposit, nor can they be applied retroactively to previously booked trips. Failure to apply a voucher within the specified timeframe will result in forfeiture of its use for that particular trip. All voucher applications are subject to verification and approval by HLTC.

DISPUTED PAYMENTS: In the event of a disputed payment for reasons other than a fraudulent charge, the administrative fees associated with a dispute will be invoiced to your account and either deducted from your refund or invoiced to you. These fees are subject to change due to payment processors rules and regulations.

TRAVEL PROTECTION: Travel insurance is recommended to help protect you and your trip investment against the unexpected. For your convenience, we offer travel protection. If you do not wish to purchase now, the plan can be purchased any time before submitting your final payment. Coverage takes effect once payment is received. If you chose to purchase outside of the time sensitive period outlined in the plan, you will not be eligible for time sensitive benefits. All plan premiums are non-refundable. MEDICAL CONDITION: We endeavor to provide the highest level of service to all our passengers. Participants who require special assistance must be accompanied by a qualified helper who assumes total responsibility for the participants' well-being. This pilgrimage demands a lot of walking and can be strenuous. HLTC is not responsible for any medical conditions that occur prior to, during, or after the tour.

LAND TRANSPORTATION AND TRANSFERS: By private deluxe motor coach.

ACCOMMODATIONS: Tour prices are per person, based on two persons sharing double or twin-bedded rooms with a private bathroom with tub or shower. In the event that one does not sign up with a roommate and is not able to be paired with another traveler, there will be a single supplement charge to the account. Single rooms subject to availability and an additional cost indicated on the brochure. Accommodations are subject to change due to upgrade, size of group, etc.

MOBILE APP: Final pilgrimage details will be available through an app before departure. Please be aware that the information on the app is regularly updated and subject to change. HLTC (Holy Land Travel Company) holds no liability for errors or discrepancies in the app's content.

MEALS: Meals in accordance with the itinerary. All beverages are extra.

TIPPING: A total of 160 Euros per person is collected to cover all standard requirements during the tour. This amount insures fair compensation for the services provided by your tour escort, local guides, and professional driver. It also includes gratuities for hotel staff, specifically for room service during breakfast and dinner. Tips will be pre-collected before the pilgrimage for your convenience.

AIRLINE TICKETS AND ITINERARY LENGTH: Air transportation to/from your destination will be economy class aboard carriers utilizing non-refundable, non-amenable tickets. Preliminary international flight schedules are available 60 days prior to departure and may change before they are finalized. Therefore, if you book the domestic flight on your own, you will be responsible for changing your domestic flights and incurring any change fees that would be generated by this adjustment. We are not responsible for changes and delays in airline schedules and do not reimburse passengers for expenses resulting from such occurrences. Travelers making their own flight arrangements should not purchase non-refundable, non-changeable tickets. We cannot guarantee the most direct routing to your final destination. If flight schedules change, we reserve the right to lengthen or shorten the itinerary accordingly, and if changes or flight schedules necessitate extra overnights, you will be charged at normal hotel rate

Note: While no changes are anticipated, there may be unforeseen occasions when certain alterations become necessary, either due to changes to the airline schedule, government regulations, travel restrictions, or any other reason. Holy Land Travel Center reserves the right to change the itinerary or name alternate dates due to such unforeseen circumstances or emergencies

SEAT ASSIGNMENT: THERE IS NO ADVANCE SEAT SELECTION FOR TOUR DEPARTURES. HLTC cannot guarantee specific seats, which are at the discretion of the airline and are pending availability. When HLTC disperses travel packages, you will receive your record locator. You can use this locator to do online seating arrangements, if permitted by the airline, any additional costs for seat selection are your responsibility. If your airline ticket is canceled for any reason, you must directly contact the airline to request a refund for your seat selection. The refund will be processed to your original form of payment, subject to the airline's terms and conditions."

BAGGAGE: Transatlantic and transpacific flights to and from the USA allow the passenger to bring one (1) checked bag, which may have a maximum weight of 50 lbs., and maximum combined dimensions of 62 inches. Also, one (1) "carry-on" with maximum dimensions of 8"x12"x20" is permitted. Luggage on domestic flights including Mexico & Canada will cost extra. Luggage is the passenger's responsibility and that of the airlines. For lost luggage, the passenger is responsible for notifying the airline directly. Check with your carrier regarding carry-on luggage rules and regulations.

PRICES: All prices are based on exchange rates and fares applicable at time of quotation and based on minimum number of paying passengers stated in the brochure and are therefore subject to change if fares change (including fuel surcharges increase), if group does not reach minimum or if exchange rates fluctuate. Minimum number of paying passengers is 30.

NOT INCLUDED: Passport and Visas, exit taxes, meals not mentioned, beverages with meals, extra beyond standard menu, excess baggage, luggage on domestic flights, telephone calls, fuel surcharges increase.

VISAS: When and if a visa or visa waiver is required, it is the passenger's responsibility to obtain one. TRAVEL AUTHORIZATION FOR EUROPE & UK: Starting in 2025, travelers from the U.S., Canada, Australia, and other visa-exempt countries will need online travel authorization to enter most of Europe (ETIAS) and the United Kingdom (ETA). This applies to all travelers, regardless of age, and includes layovers in the UK. These are not traditional visas but require basic personal and trip information.

-ETIAS: Approx. \$9 USD per person for travel to Europe

-UK ETA: Approx. €16 per person, required even for transit through the UK
