## Day by Day Itinerary

**Oct. 15 Day 1: Depart USA:** Today we board our flights with meals and beverages served aloft.

**Oct. 16 Day 2: Arrive Istanbul:** Welcome to Istanbul, formerly known as Constantinople! Upon arrival, we are welcomed by representative. After visa formalities, we head to our hotel for a welcome reception.

**Overnight:** Istanbul (Dinner\*)

**Oct. 17 Day 3: Istanbul: Eastern Orthodox Christian sites, Grand Bazaar:** Today we explore the Eastern Orthodox Christian sites of Istanbul, known in Byzantine times as Constantinople. Visit the Orthodox Patriarchate in the beautiful Church of St George and check out other richly gilded places of worship including the Church of St Mary of the Mongols, and Chora Church, famous for its glittering Byzantine mosaics and frescoes. During the day, arrangements will be made for the group to celebrate Mass privately at the hotel. After, we will have time to visit the Grand Bazaar for shopping. The Grand Bazaar is an amazing place - literally a maze of streets. It is one of the largest undercover bazaars in the world and is even divided into areas like the leather section, or the rug section.

**Overnight:** Istanbul (Breakfast, Dinner)

**Oct. 18 Day 4: Istanbul: Sultanahmet, Topkapi Palace, St. Sofia, Hippodrome:** This morning we head to the Sultanahmet district. This World Heritage-listed district is crammed with historic buildings and atmosphere to keep you enthralled for days. Full day visits to the Topkapi Palace; overlooking the Sea of Marmara and containing numerous chambers, courtyards, and royal treasures; the Sultan Ahmed (Blue) Mosque, with its six minarets and thousands of blue tiles; and the historic Hagia Sophia, now a museum, converted to a mosque from a Christian Basilica after the fall of Constantinople in 1453. During the day, the group will have time to celebrate Mass at a local church. Next, we see the Hippodrome and the Obelisk brought from Egypt.

**Overnight:** Istanbul (Breakfast, Dinner)

**Oct. 19 Day 5: Istanbul: Continue to Kavala:** Today we depart Istanbul for Kavala, Greece. Meet our new Greek guide and driver and continue through our tour of Greece, with time arranged for the group to celebrate Mass.

**Overnight:** Kavala (Breakfast, Dinner)

**Oct. 20 Day 6: Kavala/ Thessaloniki: Great Acropolis, Market Place, Theatre & Forum:** Today we visit Kavala, which occupies the site of ancient Neapolis and Philippi (Acts 16:12-40, Phil.), that today lies as a major archaeological site near Krinides where St. Paul and St. Silas were imprisoned after St. Paul's first sermon in what we today call Europe. After visiting the ruins of the great Acropolis, the Market Place, Theatre and Forum, we will have time for the group to celebrate Mass before continuing to Thessaloniki for dinner and overnight.

**Overnight:** Thessaloniki (Breakfast, Dinner)

**Oct. 21 Day 7: Thessaloniki/ Veria: Rotonda, St George Church, Galerius Arch:** This morning we visit the Rotonda, St. George Church, one of the oldest constructions in the city, the church was built at the end of the 4th century by the Roman emperor. This time period will become more alive to us as our visit will include the Galerius Arch, built a little before 305 AD in commemoration of Galerius's victory over the Persians in 297. Next is the most beautiful basilica in the city St. Demetrius where Saint Paul was imprisoned, tortured and buried. We then visit Veria, one of Paul's stops, where a Byzantine mosaic commemorates his preaching, and we will have time to celebrate Mass. We check into our hotel for dinner and overnight.

**Overnight:** Veria (Breakfast, Dinner)

**Oct. 22 Day 8: Veria/ Kalambaka/ Athens: Meteora Monastery:** This morning we leave Veria and continue to Kalambaka, a town near the Meteora Monastery. Later this afternoon we will visit the Grand Meteoran Monastery

(Transfiguration of Christ), the most beautiful Byzantine monastery. The word Meteora means literally 'hovering in the air' as all the monasteries were built on top of the high rocks. Monks have been recorded living in these caves since the 11th century. The Church of the Transfiguration is the best known of the Monasteries and is built upon the highest rock, founded by Athanasios the Meteorite, a well-known figure in Orthodox monasticism. The group will have time to celebrate Mass. We continue to Athens for dinner and overnight.

**Overnight:** Athens (Breakfast, Dinner)

**Oct. 23 Day 9: Cruise-Embark Athens: Mykonos:** Today we'll leave Athens early in the morning for Piraeus and at 11:00 a.m. sail into the Aegean Sea. Our first island is one of the islands belonging to the Cyclades group of islands. This mountainous island of Mykonos has about 400 churches and is famous for its picturesque white houses and the island's trademark, the charming windmills. Mykonos has a unique architecture of Byzantine and Western characteristics. Next, we will visit the Church of Panagia Paraportiani (Greek for Our Lady of the Side Gate) on the main square Cathedral and an old Catholic Church and many boutiques and taverns along tiny, paved streets. Return on board the ship, where the group will have time to celebrate Mass.

**Overnight:** Cruise (Breakfast, Dinner)

**Oct. 24 Day 10: Cruise Kusadasi Port & Patmos Port: Ephesus, Turkey - Patmos Greece:** This morning you will arrive at the Turkish port city of Kusadasi. From here you will travel to Ephesus, where the Blessed Virgin Mary lived with St. John in a small house on the hill behind the city. Here you will have Mass before traveling down to the ancient city where you can walk the marble roads rutted by wheels of countless chariots and pass the ruins of architectural masterpieces. It is here that St. Paul preached to the Ephesians, and where he was arrested and cast out of the city. In the afternoon you will visit the island of Patmos, where St. John wrote the apocalyptic Book of Revelations. On our excursion we will visit the cave where he lived, now the site of a monastery housing priceless icons and manuscripts. **Overnight:** Cruise (Breakfast, Dinner)

**Oct. 25 Day 11: Cruise: Santorini - Crete:** Today is the last day of the cruise. Pilgrims, at their own leisure, can enjoy visiting Heraklion on the Island of Crete, as well as Fira, the capital of the Island of Santorini. The Cruise Ship offers excursions which you can purchase onboard if you want a more structured tour of either island. Before the day ends, the group will celebrate Mass onboard the ship.

**Overnight:** Cruise (Breakfast, Dinner)

**Oct. 26 Day 12: Disembark: Athens/Corinth:** Today we disembark our cruise ship, and we will be visiting and exploring the city of Athens (Acts 17: 16-34). Acropolis with Parthenon the greatest monument of antiquity, dedicated to the goddess Athena, from here one can see Areopagus (Areios Pagos - Hill of Ares) visited by Pope John Paul II, the same hill where St. Paul gave his famous sermon of "Unknown God". Our pilgrimage will continue with a drive to ancient Corinth. Explore this city's archaeological treasures, including the Agora, the Temple of Apollo, and the Bema, the place where Paul stood trial (Acts 18). Celebrate Mass at Holy Apostles Church. We have free time for lunch. We then continue to the Areopagus, where Paul addressed the philosophers of Athens (Acts 17), then ascend to the Acropolis. We also visit the Parthenon, and Erechtheion before viewing Athens atop Mars Hill where Paul stood and preached the truth to the Gentile nation.

**Overnight:** Athens (Breakfast, Dinner)

**Oct. 27 Day 13: Return USA:** Today we board our flights home, carrying with us memories and keepsakes that will last a lifetime.

# Terms & Conditions

By making any payments (cash, credit card or otherwise) towards any tour constitutes your unconditional acceptance of all the terms and conditions stated in this brochure. Holy Land Travel Center shall be referred to as HLTC within this document.

**DOCUMENTS:** US citizens require a valid passport. Other nationalities please inquire with the appropriate embassies.

**REGISTRATION AND DEPOSIT:** Deposit of \$500 per person is required upon registration along with a signed copy of the registration form. Registrations are processed in the order received by HLTC. Final payment is due 45 days prior to departure. Late payments are subject to a \$50 late fee per week past the due date. HLTC reserves the right to cancel reservations whose payments are 30 days late and to apply applicable cancellation/penalties indicated below. No registrations can be made over the telephone.

**INDIVIDUAL CANCELLATION FEES & REFUNDS:** Upon cancellation of participation of tour by you, the registrant, for any reason, and only after HLTC receives your written cancellation via email used to register or by US mail., HLTC will then refund your payment for services not received by you, minus applicable cancellation fees per person, according to the following schedule: All refunds will be processed via check. Credit card fees are collected by the payment processor and will not be refunded.

- 1) Minimum cancellation fee is \$500 from time of registration up to 120 days prior to the tour's departure date.
- 2) From 119 to 60 days prior to departure day, the cancellation fee is \$500 + 20% of total price.
- 3) From 59 days to 31 days prior to departure day, cancellation fee is \$500 + 50% of total price.
- 4) From 30 days prior to departure day onward, no refund is possible.

**PAYMENT:** Advertised price is the cash/check discounted price. If paying with a card a processing fee will apply. Card processing fee is nonrefundable.

**BOUNCED CHECKS:** Bounced checks will incur a \$25 administrative fee.

**VOUCHERS:** Travel vouchers issued by HLTC may be applied to a new trip after the initial deposit has been made. To ensure proper processing, all vouchers must be applied no later than 150 days prior to the new trip's departure date. Vouchers cannot be used to cover the initial deposit, nor can they be applied retroactively to previously booked trips. Failure to apply a voucher within the specified timeframe will result in forfeiture of its use for that particular trip. All voucher applications are subject to verification and approval by HLTC.

**DISPUTED PAYMENTS:** In the event of a disputed payment for reasons other than a fraudulent charge, the administrative fees associated with a dispute will be invoiced to your account and either deducted from your refund or invoiced to you. These fees are subject to change due to payment processors rules and regulations.

**TRAVEL PROTECTION:** Travel insurance is recommended to help protect you and your trip investment against the unexpected. For your convenience, we offer travel protection. If you do not wish to purchase now, the plan can be purchased any time before submitting your final payment. Coverage takes effect once payment is received. If you chose to purchase outside of the time sensitive period outlined in the plan, you will not be eligible for time sensitive benefits. All plan premiums are non-refundable. **MEDICAL CONDITION:** We endeavor to provide the highest level of service to all our passengers. Participants who require special assistance must be accompanied by a qualified helper who assumes total responsibility for the participants' well-being. This pilgrimage demands a lot of walking and can be strenuous. HLTC is not responsible for any medical conditions that occur prior to, during, or after the tour.

**LAND TRANSPORTATION AND TRANSFERS:** By private deluxe motor coach.

**ACCOMMODATIONS:** Tour prices are per person, based on two persons sharing double or twin-bedded rooms with a private bathroom with tub or shower. In the event that one does not sign up with a roommate and is not able to be paired with another traveler, there will be a single supplement charge to the account. Single rooms subject to availability and an additional cost indicated on the brochure. Accommodations are subject to change due to upgrade, size of group, etc.

**MOBILE APP:** Final pilgrimage details will be available through an app before departure. Please be aware that the information on the app is regularly updated and subject to change. HLTC (Holy Land Travel Company) holds no liability for errors or discrepancies in the app's content.

**MEALS:** Meals in accordance with the itinerary. All beverages are extra.

**TIPPING:** Unless it is specified in the tour brochure, the price of the tour does not include tips and gratuities. Tipping is recommended to the tour guide and motor coach driver approximately \$6 and \$4 per person, respectively, per day to each. Hotel tips are approximately \$2 per day per person. Tips may be pre-collected before the pilgrimage for your convenience.

**AIRLINE TICKETS AND ITINERARY LENGTH:** Air transportation to/from your destination will be economy class aboard carriers utilizing non-refundable, non-amenable tickets. Preliminary international flight schedules are available 60 days prior to departure and may change before they are finalized. Therefore, if you book the domestic flight on your own, you will be responsible for changing your domestic flights and incurring any change fees that would be generated by this adjustment. We are not responsible for changes and delays in airline schedules and do not reimburse passengers for expenses resulting from such occurrences. Travelers making their own flight arrangements should not purchase non-refundable, non-changeable tickets. We cannot guarantee the most direct routing to your final destination. If flight schedules change, we reserve the right to lengthen or shorten the itinerary accordingly, and if changes or flight schedules necessitate extra overnights, you will be charged at normal hotel rates. Land Only packages do not include airport-hotel transfers.

You can use this locator to do online seating arrangements, if permitted by the airline, any additional costs for seat selection are your responsibility. If your airline ticket is canceled for any reason, you must directly contact the airline to request a refund for your seat selection. The refund will be processed to your original form of payment, subject to the airline's terms and conditions."

**BAGGAGE:** Transatlantic and transpacific flights to and from the USA allow the passenger to bring one (1) checked bag, which may have a maximum weight of 50 lbs., and maximum combined dimensions of 62 inches. Also, one (1) "carry-on" with maximum dimensions of 8"x12"x20" is permitted. Luggage on domestic flights including Mexico & Canada will cost extra. Luggage is the passenger's responsibility and that of the airlines. For lost luggage, the passenger is responsible for notifying the airline directly. Check with your carrier regarding carry-on luggage rules and regulations.

**PRICES:** All prices are based on exchange rates and fares applicable at time of quotation and based on minimum number of paying passengers stated in the brochure and are therefore subject to change if fares change (including fuel surcharges increase), if group does not reach minimum or if exchange rates fluctuate. Minimum number of paying passengers is 30.
